# **Invited Speaker**

### Jane Desmond



Jane Desmond is Professor of Anthropology and of Gender/Women's Studies at the University of Illinois at Urbana-Champaign (UIUC), USA, where she also holds affiliate faculty appointments in the Unit for Critical Theory and the College of Veterinary Medicine, and serves as Executive Director of the International Forum for US Studies: A Center for the Transnational Study of the United States. She is the founding Resident Director of the new UIUC-Animals and Society Institute collaborative annual Summer Institute in Human-Animal Studies, first launched in 2016. Jane has published widely internationally in the fields of performance studies, transnational American Studies, and on human-animal relations, and is founding editor of the Animal Lives Book Series at the University of Chicago Press. She is the author of Staging Tourism: Bodies on Display from Waikiki to Sea World (U of Chicago Press, 1999), and Displaying Death and Animating Life: Human-Animal Relations in Art, Science and Everyday Life (U of Chicago Press, 2016), selected as a CHOICE book of 2016, as well as multiple edited books and articles. A past President of the International American Studies Association (2008-2012), she holds a PhD in American Studies from Yale University, and has served on the faculties of Cornell University, Duke University and the University of Iowa.

### **Helping Wild Animals**

In recent years there has been a growing amount of interest in the ways we can aid animals in need of help in the wild. While many people are unaware of this, there are many circumstances where we can provide help to animals suffering or in risk of an early death due to causes such as natural disasters, disease, injuries, hunger and thirst, hostile weather conditions, among others. Our efforts here can be directed to aid animals as sentient individuals, not as members of species or ecosystems, due to which this cause differs from conservation. As more knowledge is gathered about how to aid animals without harming others it will be possible to aid many more animals than today. Your panellists are:

### **Animals and Music**

This panel will offer new perspectives on animals and music, analysing how human composers have been influenced by and debated the influence of nonhuman animal sounds and songs, how birdsongs are used to provide affect in contemporary sound production, how animal body parts form the material basis for several musical instruments, and why generations have found the "singing" of anthropomorphic chipmunks compelling. Mobilizing insights from multiple disciplinary approaches, including critical animal studies, historical musicology, cultural studies, media studies, ornithology, mammalogy, and the history of recording technology, this panel raises important questions about human aesthetics in relation to the cultural work of nonhuman animal sounds and songs in the past and amidst the ongoing challenges facing multispecies communities in the Anthropocene. # **Minding Animals - The Documentaries**

### Sonic Sea

Sonic Sea is a moving and provocative 60 minute documentary created by the International Fund for Animal Welfare (IFAW) and the Natural Resources Defense Council (NRDC), about the devastating impact of industrial and military ocean noise on whales and other marine life. Sonic Sea immerses viewers in the symphony of natural sounds upon which whales, dolphins and other sea animals depend for survival - and introduces the jarring cacophony of human made noises that has exploded over the past century. Shipping, naval sonar and seismic exploration are interrupting the ability of whales and dolphins to understand and navigate their world, to find each other, and even to survive. The film is narrated by Rachel McAdams and features Sting, Jean-Michel Cousteau, Dr Sylvia Earle and other ocean experts. It offers solutions and hope for a quieter ocean, and underscores that the ocean's destiny is inextricably bound to our own. Sonic Sea has been played at festivals across the globe and was nominated in 2017 for three Emmy Awards winning Best Nature Documentary and Best Music and Sound.


### **Book Recommendations**

This month we would like to announce two publications:

Over the Human: Post-humanism and the Concept of Animal Epiphany
Author: Roberto Marchesini
Publisher: Springer
Publication: 2017

This book from MAI Board member, Roberto Marchesini, presents a new way to understand human animal interactions. Offering a profound discussion of topics such as human identity, our relationship with animals and the environment, and our culture, the author channels the vibrant Italian traditions of humanism, materialism, and speculative philosophy. The research presents a dialogue between the humanities and the natural sciences. It challenges the separation and oppression of animals with a posthumanism steeped in the traditions of the Italian Renaissance. Readers discover a vision of the human as a species informed by an intertwining with animals. The human being is not constructed by an ontopoetic process, but rather by close relations with otherness. The human system is increasingly unstable and, therefore, more hybrid. The argument it presents interests scholars, thinkers, and researchers. It also appeals to anyone who wants to delve into the deep human animal bond and its philosophical, cultural, political instances. Roberto is a veterinarian, ethologist, and philosopher. He uses cognitive science, zooanthropology, and philosophy to engage in a series of empirical, theoretical, and practice based engagements with animal life. In the process, he argues that animals are key to human identity and culture at all levels.




Cyborgs versus the Earth Goddess Author: Moses Seenarine Publisher: Xpyr Press Publication: 2017

Cyborgs Versus the Earth Goddess: Men's Domestication of Women and Animals, and Female Resistance is a compelling and unusual book. For millions of years, early humans lived in gynocentric or female centred cultures which revolved around the worship of Earth Goddesses. Female led clans were ecological and managed the land sustainably throughout the Stone Age. What is more, numerous aspects of so called human civilisation were developed by prehistoric females, thousands of years before men/cyborgs domesticated animals – from fire, fireplaces, cooking, food preservation, and storage, to dance, art, medicine, philosophy, language, stories, ritual, trade, settlement, pottery, textile, calendar, metal, and more. The text includes engrossing details on specific Goddesses, such as the Goddess of animals, the Moon Goddess, the Triple Goddess, Sybils, and Oracles. The significance of hundreds of Woman/Goddess carvings found in Europe and Asia is considered, along with evidence of prehistoric women's cave art. There are vital discussions on gynocentric power, and female centred family and culture. The importance of the Mother's gift economy is also explored, especially its influence on socialism and the capitalist backlash against feminism that resulted.

### (Un)common worlds: Contesting the limits of human-animal communities

The Finnish Society for Human-Animal Studies (YKES) is proud to organise the first international Human-Animal Studies conference held in Finland. Keynote speakers are **Erica Fudge** (University of Strathclyde), **Jamie Lorimer** (University of Oxford) and **Helena Telkänranta** (University of Bristol and University of Helsinki).

Humans and other animals share spaces and create communities together. They touch each other in various symbolic and material ways, constantly crossing and redrawing communal, ethical and very practical boundaries. As of late, this multifarious renegotiation of human-animal relations has sparked intense debates both in the public arena and in academia.

How do we live together in complex places, spaces and societies, with intersecting and overlapping borders and traces of cultures, histories and politics? Furthermore, the discussions bring forth the question of how to work against the premises of exclusive human agency and interest in order to explore and imagine multispecies futures. However, the various conceptualisations of inclusive, common worlds entail a risk of disregarding or devaluing that which is not shared: the aspects of multispecies lives that cannot be or become common but that nevertheless matter for shared existences. There is also the issue of becoming "common" – of territorialisations and inclusions of some beings to the exclusion of others. What will remain the "uncommon" (i.e. unconventional) in common worlds? Moreover, are common worlds envisaged as free of political struggles and borders? What are the politics of becoming common and remaining uncommon?

We invite you to discuss and develop ideas about human animal worlds both common and uncommon. We invite presentations to this interdisciplinary conference from various fields, including but not limited to social sciences, law, arts and humanities, and natural and environmental sciences. We also invite artists to present their work. Please contact the organizers to discuss your ideas.

### Deadline for abstracts: February 28, 2018.

#### Submission guidelines:

Please send your abstract (max. 250 words) by email to <u>uncommonworlds2018@gmail.com</u> no later than February 28, 2018. Please include in your submission the title of your presentation, your name, affiliation, and contact information. We will notify you of acceptance on March 2017.

#### Conference costs and registration:

Registration for the conference will open in March 2018. Early bird registration fees (until 31 May 2018) are 110 Euros for members of the society, 130 Euros for non-members, and 90 Euros for students. Late bird registration fees (until 31 July 2018) are 130 Euros for members of the society, 150 Euros for non-members, and 110 Euros for students. The conference fee includes refreshments during the conference. Conference dinner is subject to an additional fee.

Turku is a lively academic city on the southwest coast of Finland. Originally settled during the 13th century, Turku is Finland's oldest city.
